2. PURCHASE/DEPOSIT INFORMATION

The Buyer is paying a \$500 holding fee towards the purchase price of the Dog, to the Breeder, in the month of The Dog is being sold for the total sum of \$3,000 and the remainder \$2,500 is DUE IN FULL prior to the Dog being picked up or shipped via Airline. If puppy is not paid in full five days after the agreed upon pick-up date, Breeder may offer said puppy to another owner without any further obligation to buyer.

SECTION B: TERMS AND CONDITIONS

3. CONTRACT

As a condition to the sale of the Dog, the Buyer by submitting this Holding Fee agreement, has reviewed, accepts, and agrees to sign and be bound by the Terms and Conditions of an additional Contract governing the sale of the Dog.

4. PAYMENT

The total Purchase Price of the Puppy is \$3,000.00; The Balance Due of \$2,500.00, after crediting the holding fee of \$500.00, must be paid in full at the time of delivery/pick-up of the Puppy to the Breeder. This purchase price does not include any delivery or shipping charges which is calculated separately. If the remaining balance of \$2,500.00 is not paid within five days from notification of puppy's availability, Breeder may offer said puppy to another owner without any further obligation to buyer.

There are no refunds on holding fees & failure of the Buyer to complete this purchase would subject Breeder to lost opportunities to sell the Puppy to some other Buyer & retention of the holding fees is meant to compensate Breeder for this possible loss. This holding fee signifies the intent on the part of the Buyer to follow through with the Purchase of this Puppy.

Once the holding fee has been paid, the Breeder will refrain from selling the Dog to another party, unless otherwise specified herein. However, the Breeder reserves the right to void this transaction & refund the holding fee if we learn of any reason why Buyer might not be suitable for the puppy – (i.e. Buyer is found to be an animal abuser, violent person, representative of a Pet Store, representative of a pharmaceutical research laboratory or is being proven to be difficult to communicate and work with etc.)

If the transaction is voided or if the puppy should no longer be available due to illness or through some tragic accident the Puppy were to die or otherwise be seriously injured before it goes to its new home then, of course, the holding fee will be returned to the Buyer.

5. PREFERRED METHOD OF PAYMENT

Our preferred method of payment of the balance may be made by cash, e-transfer, or bank to bank wire transfer or Money Order. We will not reserve a Puppy until the payment & this Agreement is received. Mail-in payment through regular mail is also accepted and can be arranged and discussed prior. Paypal is only available to residents of the United States of America.

6. PICK-UP/DELIVERY DATE

This Puppy will be available for the Buyer to pick up personally in Thunder Bay, Ontario, Canada or delivered to its new home after a minimum of eight weeks of age. This date is based on the Breeder's estimation of when the puppy will be naturally weaned & ready to leave its Dam. Typically, our puppies stay an absolute minimum of 8 weeks of age but can go up to 10-12 weeks of age depending on the puppy's needs and growth rate. Should the Buyer not be able to pick/arrange delivery of their Dog within the two-week grace period after designated pick-up date outlined by the Breeder, the Buyer will be subject to Boarding Fees of \$30 per day. This boarding fee goes towards the time and effort the Breeder will have to spend socializing, caring for, training and feeding the Dog.

7. PUPPY DESIGNATION

Buyer understands that the Breeder will choose a companion puppy for the Buyer after any Show Prospect/Breeding Prospects puppies have been selected to as the Breeder retains the right to always select for the FoxFire Beagles program foremost. Buyer is aware that if the Breeder has a Dog that matches the Buyer, determined so at the sole discretion of the Breeder, and Buyer refuses such Dog, NO refund of the Holding Fee will be owed to the Buyer as the Deposit will then cover the monies lost by the Breeder. Dogs are not placed based on colour or markings, but on appropriate temperament for their companion homes with physical traits being secondary.

8. PUPPY PREFERENCES

The Buyer has the following preferences in regards to physical and mental traits of the Dog, which the Breeder will attempt to accommodate, if possible:
